

# Legal & Financial Document Locator

Do you know where your dad's birth certificate is or where your mom keeps her long-term care insurance policy information? Planning ahead in case of a medical crisis can make all the difference in an emergency situation. Knowing where official records are located as well as having copies of important legal and financial documents can make your job as a caregiver a lot easier. This Legal & Financial Document Locator is intended to be a helpful tool for use at home to organize your loved one's legal and financial records. Be sure to keep it in a secure location.

#### **Getting Started**

Which documents are most important? The answer is different for everyone. The items listed below on the Legal & Financial Document Locator can serve as a guide to help you decide what is important to keep track of.

There are some <u>important legal documents everyone should have</u><sup>1</sup> in place. Many of these documents are referred to by a variety of names, and many sound alike. Additionally, state laws vary, so find out about the rules, requirements, and forms used in your state.

Name	Also Known As	Purpose
Will	Last will and testament	Allows you to name the person you want your money and property to go to after you die
Living Will	Advance health care directive, medical directive	Allows you to state what kind of health care you do or don't want if you become too sick to make your wishes known

Name	Also Known As	Purpose
Durable medical power of attorney <sup>2</sup>	Durable power of attorney for health care, health care power of attorney, health care proxy	Allows you to name the person you want to make medical decisions for you if you can't make them yourself
Durable financial power of attorney <sup>3</sup>	Power of attorney for finances	Allows you to name someone to act on your behalf for any financial task, even if you become unable to make your own decisions

If your parent hasn't named a durable medical or financial power of attorney, talk to them about why it's crucial<sup>4</sup> they have those legal documents in place. If your loved one is struggling with memory loss, it's especially important to take steps early to protect their financial affairs and medical treatment wishes<sup>5</sup> before they are unable to make those decisions on their own.

#### **Using the Document Locator**

The Legal & Financial Document Locator can be a handy tool to help you organize important documents, property, and contacts. Use it to help organize your loved one's personal information.

There are numerous blank spaces provided so you can personalize your list. For example, if your loved one has a pet, you may want to include the name and address of the veterinarian.

Once completed, provide copies to a few trusted family members as well as your loved one's lawyer and their power of attorney to have in case of an emergency. Make certain it is always kept in a safe place to protect personal information.

- Ensure your loved one has a financial POA and medical POA, a living will, and a standard will or living trust.
- □ Put their important papers and copies of legal documents in one place.
- □ Tell a trusted family member where you put the important papers.
- ☐ Fill out the Legal & Financial Document Locator.
- ☐ Provide copies to a few trusted family members as well as your loved one's lawyer and their POAs.
- ☐ Check each year to see if there's anything new to add.
